Who can use this form

The passport applicant (you or a child) must:

- be a person of Aboriginal and/or Torres Strait Islander descent
- identify as an Aboriginal and/or Torres Strait Islander
- be accepted as an Aboriginal and/or Torres Strait Islander by the community in which you are from or in which you live.

When to use this form

Use this form if you cannot provide proof of Australian citizenship.

This includes when you:

- cannot get an Australian birth certificate
- cannot obtain a late registration of birth in Australia
- were born on or after 20 August 1986 and cannot present evidence of your parents' or grandparents' Australian citizenship at the time of your birth
- have different names on your cardinal documents and personal identification documents

Instructions for representatives completing this form

You must:

- belong to one of the categories in Section 4
- not be a person with parental responsibility for, or related to, the applicant by birth or marriage
- confirm the applicant's heritage through government agencies or an Aboriginal and Torres Strait Islander organisation
- be contactable by telephone

Important information

- The applicant's family can originate from a different community to where they live now.
